POLICIES AND PROCEDURES: I have received, read, understand and agree to adhere to the policies and procedures of The Dance Center of Greensboro, Inc.

REGISTRATION AND TUITION INFORMATION: All students must be registered. Students will not be able to attend class until the registration form is filled out, signed and appropriate tuition is paid. All classes and tuition payments are non-refundable except in the case of serious illness or injury (documented by doctor's verification). The Dance Center of Greensboro, Inc. reserves the right to cancel any classes due to insufficient enrollment at which time a full refund will be given for the cancelled class. Please note your registration for any class is not complete until appropriate payment is received in full.

WAIVER OF LIABILITY A: It is the parent/guardians responsibility, unless the participant is over 18 years of age, to accompany the child into the studio. Please keep your child in the studio until their class is called. You must return to the studio at the end of their class to ensure the safety of your child. We provide a viewing window for classes; the viewing window will remain open unless it becomes distracting at which time it will be closed. No child is to leave the building without an adult. No one other than registered students is permitted in the studios with the exception of parent observation days. Students must arrive to class with their hair tied back and proper shoes. No jewelry, watches, or cellular phones are allowed in the dance classes.

WAIVER OF LIABILITY B: My permission to participate in this exercise program is voluntary. I am free to begin or discontinue this program at any time. I will perform aerobic and anaerobic exercise. The Dance Center of Greensboro staff person may stop my participation at any time because of signs of fatigue, or I may stop when I wish to because of personal feelings of fatigue or discomfort. There exists the possibility of certain changes occurring during any exercise program. I understand these include abnormal blood pressure, fainting, disorders of heart beat, and in rare instances heart attack. I understand that every effort will be made to monitor my well being; however, I am responsible to monitor my own well being by checking my heart rate and listening to my body during the exercise session. I understand The Dance Center of Greensboro or The Dance Center of Greensboro's staff cannot be held liable for any injuries, diseases, or health problems that may present themselves after beginning participation in this exercise program. I understand that all liabilities of participation in this exercise program rest with the participant. PAYMENT: The registration fee and 1st month of class tuition is due upon the registration of each participant. All monthly accounts are considered past due on the 10th of each month. Monthly payments will only be accepted through the automatic bank draft or automatic credit card authorization process. DCG will no longer accept checks for monthly tuition payments. If payments are not received by the 10th of each month, a \$25.00 late fee will be automatically added to the balance due. Checks should be made payable to "The Dance Center of Greensboro" - our acronym DCG is acceptable. A \$30.00 fee will be charged for any returned checks. Please keep your contact information current with the office throughout the year.

ATTENDANCE: Attending class is the responsibility of each student and family. No refunds/credits are issued for missed classes. Classes missed for any reason should be made-up in any other appropriate level class on our schedule. The Dance Center of Greensboro reserves the right to cancel any class for which there is insufficient registration.

ADD/CHANGE/DROP FORMS: Any change in a student's registration must be submitted in writing via the Add/Change/Drop forms available in the Office. Any student who wishes to withdraw is required to submit an Add/Change/Drop form 30 days (1 month) prior to the withdrawal.

_____(Please initial) RECITAL PARTICIPATION: All students are expected to participate in the Spring Recital, tentatively scheduled for Sunday June 5th. There will be a non-refundable recital fee of \$35.00, assessed to all accounts in January 2011.

_____(Please initial) POINTE PLACEMENT: Pointe work is an extension of ballet, DCG typically begins Pointe in connection with Intermediate level Ballet Classes. However, students will only be able to go on Pointe if they are able to do safely, without risking injury to the growing bones and joints, To ensure our student's safety, instructors will only grant permission to begin Pointe when the student is physically capable. Physical capabilities include: Adequate flexibility of the foot and ankle, Adequate strength of the foot, ankle, leg and torso. Adequate turnout to maintain proper alignment. Overall mature work ethic and focus that indicates stability in the development of the student.

_____(Please initial) IMPORTANT STUDIO NOTICES: All important studio notices will be posted on the website (www.dancecentergso.com) and on the notice board at the studio. Information regarding closures, other than holidays published on the DCG calendar, will be available on the website, on the answering machine and on local television stations when applicable. Make up classes will be permitted in any other appropriate level class on our schedule.

_____(Please initial) PERFORMANCE OPPORTUNITIES: DCG Elite Sr. & DCG Elite Jr. Performance Teams. The Performance Team is geared towards students who are interested in performing in our Nutcracker Suite Performance and competing throughout the academic year at local events as well as attend dance DMA and Cecchetti Ballet workshops and conventions, The Performance team(s) meet in addition to their regular classes. Anyone wishing to participate in the performance team(s) must be enrolled in a ballet class at DCG and wither be invited or successfully audition for a spot on the team(s).

_____(Please initial) OUR FACILITIES: All students, and their families, are expected to be respectful of The Dance Center of Greensboro facilities. No food or drink is allowed in the dance studios at any time. Adequate supervision must be provided for siblings at all times. It is dangerous and distracting to have young children running down the hallways and lobby areas.

_____(Please initial) DISCIPLINE AND CONDUCT: DCG Instructors, Parents, and Students will conduct themselves at all times in an appropriate manner while at DCG. We will teach each student to work hard and seek to encourage each other. Politeness and courtesy are highly valued. Proper respect for the instructors, staff and fellow students is expected at all times from students, parents, and siblings. DCG reserves the right to suspend or dismiss any student, parent/guardian or caregiver whose attitude, attendance, or conduct is found to be unsatisfactory.

_____(Please initial) PARENT/TEACHER CONFERENCES: Teachers are available for private conferences. Please contact the studio office to request and schedule an appointment with the teacher you would like to meet with. Class schedules do not allow adequate time for private discussions between classes during the week.

_____(Please initial) DISCIPLINE POLICY: If disciplinary action is required the process for discipline will be as follows: 1. The instructor will talk with the student about the problematic behavior. 2. The parent/guardian of the student will be called and informed of the students problematic behavior. 3. The Studio Director will be notified and the student will be suspended from class for one week. 4. The Studio Director has the option to expel student from all classes for the remainder of the dance year.

The Jr. and Sr. Performance Teams will compete in a few (2-3) local dance competitions within the state of N.C. during the 2nd semester, tentatively scheduled for March-May.

Students have the option of participating in the Jr. and Sr. Performance Team, 1st semester only. It is not required that all participants remain on the team after *The Nutcracker Suite* Performance and participate in dance competitions. However, it is required that students interested in participating in dance competitions during the 2nd semester have to participate in the Performance Team from Sept-May, including *The Nutcracker Suite* Performance. The additional rehearsal time focused on the art of Classical Ballet Technique is crucial for the technical demands of achieving a successful competitive performance level.
